### **Exhibitor Liability Insurance Program**

As a standard requirement for all of our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. American Association of Orthodontists and Orange County Convention Center shall be named as additional Insured. This insurance must be in force during the lease dates of the event, April 27-May 4, 2016.

There are no applications to fill out. Simply purchase your insurance, which is already pre-filled with all of the proper show information, directly online using a credit card.

- \*Should there be a claim, it will not tarnish your policy and rates. And, unlike most corporate policies, there is no deductible.

Having insurance will protect your company, employees, and volunteers, should a claim arise against you for something that occurred at your booth.
